Mr West will obtain quotes for the work needed and councillors will agree by email during the month so that the work can be carried out as soon as possible.

There is a natural entrance from the main area of The Green to the extension, so it was suggested that the ditch should be left as it is for a while to see if it causes any problems, as the Tree Officer at ABC is concerned that if it is dug out the work will disturb the tree roots.

Village Green Car Park – Correspondence from Resident re Water Main to new build

Councillors unanimously agreed to the residents’ request to install a water main to their new property.

The parking situation on the Car Park has improved. Mr Jones and Mr Wood will speak to the garage owner in an attempt to ensure that the situation continues.

Councillors unanimously agreed to apply for a Tree Preservation Order.

Request for Banner from Fitness Group

Councillors unanimously agreed to this request as long as the banner is no larger than the one used to advertise Parish Council meetings and to ask for a donation of £10 per week towards the upkeep of the Village Green.
